Think of AI in 3 Simple Steps



Predictive Al

Forecasts financial trends and anomalies based on historical data patterns, helping identify audit risks before they become issues.




Generative Al

Creates new content like financial reports, advisory notes, and client communications based on your specific requirements.



Agentic Al

Takes autonomous actions on your behalf, such as scheduling tax filing reminders or flagging compliance deadlines automatically.



Behind the Magic of LLMs

Massive Training Data

LLMs are trained on billions of documents, including financial regulations, accounting standards, and business literature.

Pattern Recognition

They identify patterns in text to understand context and relationships between financial concepts.

Next Word Prediction

At their core, LLMs predict the most likely next word based on context, creating coherent financial analyses and recommendations.

Occasional Hallucinations

Without proper grounding in verified data, LLMs can generate plausible but incorrect information about tax codes or regulations.



The #1 Risk You Should Know

Hallucination in Finance Terms

Al may generate a wrong GST rule if not grounded in your data

Hallucinations occur when AI confidently presents incorrect information as fact:

- Inventing non-existent tax exemptions
- Citing outdated regulatory requirements
- Creating fictional accounting standards
- Misinterpreting complex financial structures

Always verify Al-generated financial advice against authoritative sources!

Use Case - GST Interstate Commerce Advisory

Place of Supply Advisory

Clients struggle with interstate GST implications. Al quickly clarifies warehouse movement complications.

Instant Rule Explanations

Generate CGST vs IGST rule-based explanations in seconds, not hours.

ITC Eligibility Clarity

Provide clear Input Tax Credit guidance for complex interstate transactions.

Scenario Analysis

Cross-border consultancy creates complex GST implications.

- Indian consultant to foreign client
- Foreign consultant to Indian client

Al Tools Deployed

Leverage multiple AI systems for comprehensive solutions.

- ChatGPT
- Gamma for client-ready visuals

Deliverable Value

Transform complex international tax issues into clear guidance.

- Export of services determination
- Place of Supply rules clarification

Indian to Foreign Client

Typically qualifies as "export of service" under IGST Act.

- Zero-rated supply (no GST)
- Must meet specific criteria under Section 13
- Payment in foreign exchange required

Foreign to Indian Client

Usually taxable under Reverse Charge Mechanism.

- Indian recipient pays IGST
- Place of Supply is recipient location
- ITC may be available to recipient

Acquisition Options

Direct Property Purchase: Simpler route with cleaner separation.

LLP Acquisition: 100% ownership transfer with potential stamp duty savings.

Strategic Question

Should the Trust buy the LLP or just acquire the property from the LLP?

Advanced Reasoning

Options \rightarrow Outcomes \rightarrow Opinion methodology guides our analysis.

Challenge

Biscuit manufacturer needs 12-month procurement planning for wheat and maize.

Decisions required on domestic storage vs. international imports.

Analysis

Gemini DeepResearch processes multiple data streams:

- 5-year crop yield trends
- Fertilizer availability
- Weather predictions
- MSP vs. global pricing

Deliverable

Auto-generated infographic with:

- Supply-demand projections
- Weather-risk overlay
- Import dependency ratio
- Monthly MT recommendations

Business Value

Transforms agricultural data into strategic procurement decisions.

Reduces research and report design time by 5-8 hours.

Time Efficiency

Security Consideration

Public cloud AI - only suitable for nonsensitive, publicly available documents.




